WELCOME TO FIRS 2024

Dear FIRS Members,

Welcome to Berlin for the 18th Conference of the Financial Intermediation Research Society (FIRS). This year marks the 20th Anniversary of FIRS, which held its first conference in 2004 in Capri, Italy. Over these 20 years, FIRS has grown substantially and is now arguably one of the top international conferences in financial intermediation and financial economics more broadly. This year, we received almost 1,600 submissions, a new record, and we expect more than 360 participants at the conference. We thank you for your continued support and for sharing your research with us. The high quality of the submissions made the final selection of the 150 papers for the program very difficult.

KEYNOTE SPEAKER

Albert S. "Pete" Kyle

Charles E. Smith Chair Professor of Finance University of Maryland Robert H. Smith School of Business



Albert S. "Pete" Kyle is the Charles E. Smith Chair Professor of Finance at the University of Maryland's Robert H. Smith School of Business. Kyle's foundational research analyzes the informational role of prices, which is central to the functioning of economies. In his seminal 1985 market Econometrica paper "Continuous Auctions and Insider Trading" he asks how quickly information is incorporated into market prices. He shows that dynamic trading by informed traders allows such traders to make a profit and affects the liquidity and depth of the market; trading by informed traders

has price impact and markets are not infinitely liquid. In his influential 1989 *Review of Economic Studies* paper "Informed Speculation with Imperfect Competition" he shows that, when traders are imperfectly competitive, prices reveal less information than in competitive equilibrium and are not fully revealing in the limit. His subsequent research on market structure includes work on contagion, high frequency trading, and market manipulation.

He is a Fellow of the American Finance Association and a Fellow of the Econometric Society. He holds an honorary doctoral degree from the Stockholm School of Economics. He received the 2023 Wharton-Jacobs Levy Prize for Quantitative Financial Innovation and the 2018 CME Group-MSRI Prize in Innovative Quantitative Applications. He was a Director of the American Finance Association.

He was a staff member of the Presidential Task Force on Market Mechanisms (Brady Commission, 1987), a consultant to the SEC (Office of Inspector General), CFTC, and U.S. Department of Justice, a member of NASDAQ's economic advisory board, a member of the FINRA economic advisory board, and a member of the CFTC's Technology Advisory Committee.

Kyle taught at Princeton University (1981-1987), the University of California Berkeley (1987-1992), and Duke University (1992-2006). He earned his B.S. degree in mathematics from Davidson College (summa cum laude, 1974), studied philosophy and economics at Oxford University as a Rhodes Scholar from Texas (Merton College, 1974-1976, and Nuffield College, 1976-1977), and completed his Ph.D. in economics at the University of Chicago in 1981, while working as a trader at the Chicago Board of Trade.

DENIS GROMB AWARD

FOR OUTSTANDING CITIZENSHIP IN FINANCIAL ECONOMICS



Following the untimely passing of Denis Gromb in October 2022, the Financial Intermediation Research Society (FIRS) established an Award in his honor and memory. Denis was an insightful scholar, who served as a Director and President of FIRS. He was also exceptionally generous in helping others, especially junior colleagues and doctoral students, and a role model for outstanding citizenship in the profession.

The Denis Gromb Award for Outstanding Citizenship in Financial Economics is meant to recognize people who, like Denis, selflessly strive to make the profession better through their mentorship, leadership, dedication, and academic citizenship. The Award, along with a cash prize, will be given biennially. The inaugural Award will be announced at this year's conference during the FIRS Business Luncheon.

Recipients of the Award should have displayed the academic citizenship qualities for which Denis Gromb was well known within the financial economics profession. Specifically, recipients shall be recognized for fostering a research and work environment that is collaborative, unifying, and principled through, for example,

- their mentorship of students and faculty in the field of financial economics,
- their commitment to create positive externalities for members of the profession,
- their disposition to generously contribute time and effort to help their peers, and to go above the "call of duty" to help others in the profession,
- their willingness to engage in and stand for initiatives that have important and significant welfare implications for the profession at large,
- their disposition to lead by example, and/or
- their overall dedication to the profession.

The Award is funded through donations and, to date, FIRS has raised over \$41,000 towards its goal of raising \$50,000. 
